- Together with the Project Manager and/or Project Superintendent, look ahead, organize and coordinate work schedules of all subcontractors on project.
- Promote rapport and team work among field crew.
- Know and comply with the Company's safety rules/policies and OSHA regulations, including hazardous communication, fall protection plan, and confined space program.
- Ensure that all Osborne employees, subcontractor employees, and visitors to the jobsite comply with company safety policies and procedures.
- Assume other responsibilities as assigned.
